Food was stocked 6 inches above the ground. The floors in the restaurant were clean. Food items in the refrigerators and freezers were covered. The ice machine was clean and the scoop was stored properly. The ice cream scoops were stored in running clean water. The food handler certificate for Anissa Rosales expires April 19, 2027.
