The water at the three compartment sink and the dishwasher was above 120°F. Food was stored 6 inches off the ground. All refrigerators maintained a temperature below 41°F. The chlorine level of the dishwasher was above 50 ppm. The food Manager safety certificate expires March 2, 2028.
