Overall Inspection Comment:

Food program manager certificate belongs to Daljit Singh, expires 7/3/2028. (ServSafe). 3 compartment sink has hot water reaching over 120F. Floor sinks are observed clear of debris. All reach-in refrigerators and freezers in the kitchen area measure below 41F. The walk-in refrigerator in the sales area measures below 41F when measured from the walk in.

All cold foods in the reach-in and walk-in observed well organized. All food items were appropriately covered to prevent contamination. Cold holding food items measure below 41 F. Hot holding foods measure over 150F.

All hand washing stations were observed fully stocked with soap, paper towels and hot running water.

All foods were observed above 6 inches from the floor. Cans were observed free of damage or bloating. Facility is clean and maintained.

Please review the above noted violations regarding food handler cards and the range hood. Please take the necessary corrective action and provide documentation to our department within 30 days. A reinspection to verify compliance may be conducted at no cost; however, any additional re-inspections for the same purpose are billed at \$245 per inspection.
