Overall Inspection Comment:

This facility sells only prepackaged food items.

All refrigeration units measure below 41F and have operational lighting. No expired or adulterated foods observed.

Cans were observed free of denting or bloating.

All food items are displayed and stored at least 6 inches above the ground.

There is no hot holding or kitchen prep area.

Baby food and formulas are observed within sell by dates. Some premixed formulas (Similac 6 packs) are expiring in April of 2024. Some powdered formula (Neocate DHA/RHA; Enfamil Soy based infant formula) expires June 2024. Several others expire later in 2024. Please ensure these are removed from shelves and not sold after the use by date.

Restrooms are observed in clean condition with soap, warm water, and air dryer.

Damaged food items are clearly separated from the food to be sold.

No evidence of pest or vermin infestation is observed.
