Inspection on this date with Emma Woodward. All hand wash sinks in the kitchen and bathroom were stocked with paper towels or hand dryer, soap and warm water. All refrigerators maintained a temperature of 41°F or below. Food was covered. Food in storage areas was 6 inches above the ground. The food prep area, floors, and drains were clean and free of debris. Water at the three compartment sink was 120°F. QT levels for the towel bucket was 200 ppm. The restaurant is receiving monthly pest control service. The certified food safety manager certificate expires April 6, 2028.

Cold storage units were below 41F.

All food was stored off the ground.

Sanitizer water was recorded to be 300ppm Quat.

There was a minor presence of flies(3~), facility states they do routine pest control, please provide the most recent invoice.

Food handler cards for manager and most staff were provided. Two employees did not have theirs due to being new hires, please provide proof of completion via email when they are completed within 1 month.
