Overall Inspection Comment:

Facility inspection was conducted and the following is observed.

Facility serves teas and coffees along with dry snacks.

Prior to start of the inspection, it was noted that the facilitiy is trying to open a barbecue serving area next to the tea serving area. This has currently not been approved by County of Kings Public health, Environmental division. According to the operator, the barbecue will be cooked in a smoker that is not located at the facility. The facility does not have adequate cooking equipment to handle this operation. The operator has purchased commercial grade hot holding unit and a hot holding serving unit, bun toaster unit for serving purposes without prior notification to Public Health Office. The operator is notified to come into the office of public health to discuss this further.

Handwash Sink hot water temperature noted above 100F. Paper towels and soap available at the handwash sink. This facility has one handwash sink.

3 compartment dishwasher sink running hot water temp noted below 120F.

All refrigeration units measured noted below 41F.

Food Manager Certification available on site for review. Current and Active.

Cleanliness is satisfactory. Clean all equipment after use to avoid cross contamination.
