Overall Inspection Comment:

Inspection on this date with David Escalante. The handwash sinks in the kitchen and bathrooms were stocked with paper towels, soap, and hot water. All refrigerators maintained a temperature of 41°F or below. Water at the three compartment sink reached at temperature above 120°F Fahrenheit. Chlorine bleach is used as a sanitizer. The food prep area was clean. Food in dry storage areas was stored 6 inches above the ground. The food manager safety certificate expires June 3, 2025.
