Today observation of the nutrition hall kitchen the following were observed,

(During inspection there are food preping activities)

Handwash sink have hot water observed temperature reading at 100F and above. Station stocked with single use paper towel, and hand soap.

3 compartment sink have hot water observed temperature reading at 120F and above. Using bleach as sanitizer. Chemical test strip on site.

Vent hood was observed clean and no buildup. Floor and wall no debris observed.

Freezer units observed working with temperature reading at 13F and below, frozen items observed. Walk-in cooler tempature reading observed at 41F and below.

**Walk-in freezer unit are not in operation, used storage. Verified no food item in unit. Dry storage area are neat and stored items 6inch above floor on racks.
