Overall Inspection Comment:

Facility inspection was conducted and the following is observed.

Handwash Sink hot water temperature noted above 100F. Paper towels and soap available at the handwash sink. This facility has one handwash sink.

Multiple 3 compartment warewashing sink running hot water temp noted above 120F.

Ansul ventilation hood noted with some grease buildup on the vents. Clean as needed to avoid grease buildups.
All items in the dry storage areas noted at least 6 inches off the ground.

Cold holding temperatures for Chicken wings, diced chicken, diced pork, diced beef, tri tip beef among other items noted to be below 41F in display cold holding case.

A second display cold holding with Fish and shrimp noted below 41F.

Third display cold holding case with cheeses noted below 41F.

Items like green and red salsa, beans, rice, guacamole noted in a cold holding unit with labels. Temp noted below 41F.

Food Manager Certification available on site for review. Current and Active.

Facility also serves as a commissary kitchen for 4 mobile units according to the operator. Waste water dumping connection noted on site. Waste food grade oils are also dumped in a secure container at site by the food mobile units according to the operator.

Cleanliness is satisfactory. Clean all equipment after use to avoid cross contamination.

Facility noted pest free and pest control conducted on a monthly basis.
