Routine Inspection was done on January 17,2025.

All handwash sinks were stocks with papertowels and soap. Hand sinks dispensed water reaching above 100F.

Please remember to keep all handwashing sinks clear of equipment, so that employees can wash hands when working.

Most refrigeration units were temperatured at below 41F. Refrigeration unit holding dairy products was temperatured at below 45F. Please be sure to have designated employee food area in walk-in or reach-in refrigerator to keep food for sale and personal consumption separate. Tamales for employee consumption were observed in walk-in during today's inspection.

Restroom was functional and stocked with soap, and papertowels. Handwash sink in the restroom dispensed water reaching 100F.

3-Compartment Sink reached a temperature of 120F. Quatinary ammonia was obeserved to be used for sanitization. Facility did not have Quat test strips on site.

Food managers and pest control records were reviewed and are up-to-date.
