Facility inspection conducted and the following is observed;

Facility has a bread/baked goods reach in and self serv case. According to the operator and the label on the case shows Grullense Panaderia as the bakery for breads. According to the operator, Grullense panaderia refills and restocks the case every 3 days and takes the leftovers back.

There is no hot holding or kitchen prep area.

This facility sells only prepackaged food items. All food items are displayed and stored at least 6 inches above the ground.

All refrigeration units measure below 41F and have operational lighting. No expired or adultered foods observed. Clean the interiors of the refrigration units to avoid buildups from spillages or damaged goods.

Facility maintains a general level of cleanliness.
