Canned goods were observed in good condition with no extensive denting or bloating. Rice and pasta products were observed with no evidence of adulteration. All food items are observed stored at least 6 items above the ground. Foods are being rotated appropriately. The only refrigerators in the facility are used for drinks/sodas and are located at the front of the store near the registers. All of them were maintained below 41F. The facility does not consistently carry baby food items. Today, there were no items in stock; no baby food items are observed in stock past the required sell by date. Thank you.
