Overall Inspection Comment:

At the request of the operator, Troy Hommerding and Liliana Stransky met with the management team at Sequoia Inn today to review the use of their kitchen space for food preparation. The following findings were discussed:

The kitchen space was not designed for commercial use. The stove, hood, dishwasher and refrigerator are not commercial grade. The current kitchen set-up will not be permitted for food preparation for hotel guests. The space can serve as an employee break room only.

In order to prepare food, all equipment must meet commercial standards (NSF,UL,ANSI) and at a minimum, the installation of a 3 compartment sink (indirectly plumbed) and a separate hand washing sink would also be required.

In light of these requirements and costs involved, management has proposed an alternate menu for guests by serving only pre-packaged foods and drinks. A commercial grade refrigerator will be purchased and installed to store these items. The present sink can be used for hand washing as long as hand soap, paper towels and cold/hot water are present. Once the refrigerator is installed, please contact our office to request an inspection.
