Routine food/grocery inspection today. Manager on duty is Joshua. Observations from the inspection:

All refrigerators measure below 41F. Reach-in refrigerators are organized well to prevent contamination.

The salesfloor is observed organized and free of debris accumulation. All food items are stored at least 6 inches off the ground.

Canned items were checked for bloating and excessive denting. Some items were removed from the shelf due to excessive denting. See the above note for the details.

The facility did not have baby formula or jarred baby food. The packaged food items present were within the sell date.

The restroom is observed clean with warm water, soap, and paper towels.
