All refrigerators maintained a temperature of 41°F or below. Food in hot holding areas maintained a temperature above 135°F. The floors, walls, and the hood in the kitchen were very clean. The food manager safety certificate expires July 7, 2024. Please make sure to update the certificate before it expires. The permit to operate for the facility is currently expired. Permit fees must be paid prior to April 5, 2024 to prevent possible closure for operating without a valid permit to operate.
