



PROPER STORAGE OF HOUSEHOLD GENERATED SHARPS & PHARMACEUTICAL WASTE

HOME -GENERATED SHARPS (needles, syringes with needles and lancets)

- PREVENT needle stick injuries by not disposing of sharps in residential solid waste, recyclable materials or green waste collection containers. It is an illegal practice in California.
- STORE sharps waste (lancets & syringes) safely in puncture resistant containers, such as plastic jars or mugs until you can take them to a drop-off site for proper disposal.
- KIOSKS are now located through out Kings County for the safe disposal of sharps, free of charge to the public. Refer to the back of the handout for a location near you.
- FREE sharps containers remain available to the general public at KCEHS and these will continue to be accepted at Kings Waste Recycling Authority (KWRA) for their disposal.

HOME – GENERATED PHARMACEUTICAL WASTE (expired & unused prescriptions or over the counter medications)

- NEVER discard unused or expired medications in a bathroom sink, flush them down the toilet or throw them away in the trash. These practices increase the risk of groundwater contamination and place poisonous substances at the reach of the general public, including children.
- STORE medications in their original container or a clear plastic container, away from children, until you can safely dispose of them.
- KIOSKS for both medications and sharps wastes are now located through out Kings County. Refer to the back of the handout for a location near you.
- KWRA only accepts pharmaceutical waste during Household Hazardous Waste Collection Events.
