Retail Market inspection conducted and the following is observed;

Facility is a retail market with cold holding areas for ice cream, frozen foods (Burritos, Pre Packaged Anchovies) and some dairy milk products. Temperature observed below 41F.

Soda machine area noted with some dirt and debris buildup. Soda machine dispensing nozzles noted clean during this inspection.

Other areas of the market walked and general cleanliness is noted unsatisfactory. Shelves checked for expired or damaged canned goods.
