Overall Inspection Comment:

A routine inspection was conducted on this date. The food program manager certification recently expired. Please ensure this is renewed as soon as possible and provide documentation to our office within 30 days.

All cold-holding units are measured below 41F.

Hot water is available at the warewashing sink. Please ensure the water heater remains set high enough to provide water at least 120F.

The handwash sink has warm water, soap, and single use paper towels available.

Food prep surfaces are observed clean and used appropriately.

The equipment throughout the facility is dated, however, it is generally able to maintain proper food temperatures. Please see the violation above regarding the freezer, and provide documentation of the corrections within 30 days.

The floors are observed clear and free of debris.

No evidence of rodent or other pest infestation is observed.

The dry food storage and display is at least 6 inches off the ground. No signs of adulteration or other food spoilage was observed.

Please note the stated violations and provide documentation of correction to our office (email photos / copies of certificate is sufficient) within 30 days. If a re-inspection is required, the first re-inspection is conducted at no charge. Any subsequent re-inspections have a fee of \$246 per inspection.
