Inspection on this date with Ashley Flores. The hand wash sinks in the kitchen and bathroom were stocked with paper towels or hand dryer, soap and warm water. Water at the three compartment sink reached the temperature above 120°F. QT level was 200 ppm. All refrigerators maintained a temperature of 41°F or less. Food in the refrigerators was covered. Food was stored 6 inches above the ground. All of the ice machines were clean, and the ice coops were stored in a clean container. The food prep area, floors, and drains were clean. The restaurant is receiving pest control service monthly. The food handler certificate expires October 30, 2026. The restaurant is very clean. No violations were noted during the inspection.
