Inspection is conducted and the following is observed.

Facility has Meat Preparation Area, Rotisserie Chicken Baking/ Oven Area, Multiple Walk in and Reach in Refrigration units, Infant Foods Area, Canned Goods and Sealed Goods Areas.

Rotisserie Chicken Baking/Oven Area -

Handwash sink Available. Taps noted with grease and grime buildup upon touch. Dishwash sink is 3 compartment dishwashing sink. Taps noted with grease and grime buildup. Clean regualry to avoid buildups.

Adequate Handwash Water temperature of above 100F. Paper Towels and Soap available.

Area needs to be well maintained and free of food debris and sinks need to be maintained free of buildup.

Raw Meat Preparation and Holdiong Case -

3 compartment dishwashing sink noted. Water temp noted above 120F.

Handwash sink which is also the dishwashing sink, noted well stocked with paper towels, soap and running water temperature above 100F.

Walk in Refrigration unit noted with condensate on floors. Also noted some raw chopped meat products on the floor. Keep refrigration unit clean. Noted below 41F.

Dispaly meat case noted clean with temperatures for Raw Fish, Raw Shrimp, Raw Chicken, Raw Steaks, Grounded Beef, Groud Pork below 41F. Display case noted with separation between meats to avoid cross contamination.

Cold Holding Units -

All Walk in refrigeration units noted below 41F.

Dairy products reach in refrigeration units noted below 45F.

Display meat area refrigeration unit noted below 41F.

The reach in refrigeration units in the aisles were noted with some foods items spilled inside the units. Keep all refrigtaion units free of spills, leaks or damage to avoid cross contamination.

Infant Foods checked for expiration dates and overall condition of the sealed containers and foods.

General Goods -

Noted a few dented cans around the Facility. These cans were removed off the shelf by the manager and stored in the back for disposal or return to provider.
